**EASY APPLICATION INSTRUCTIONS**

**APPLY USING A ROTARY SPREADER - RECOMMENDED SPREADER SETTING IS 60%.**

**DAY 1** Apply Mole Scram to 50% of lawn starting at area furthest from where you want moles to exit, water for 20 minutes.

**DAY 2** Apply Mole Scram to remaining 50% of affected lawn. Again water application for 20 min. Locate mole runways, punch 1" holes every 10 ft. and drop granules into holes, then cover with soil. Also apply to the ends of each runway. Please be patient, while Mole Scram is fast acting, it may take up to 1 week for the mole to associate their discomfort & hunger with the Mole Scram™ treated area.

**WATERING** or rainfall is the key to activation as it draws the oil from the granules into the soil. This action rapidly begins the repelling process.

**FOR LAWN AND GARDEN AREAS OF 7,000 OR LESS SQUARE FEET**, we recommend covering the entire area.

**REAPPLY** whenever mole activity or new tunneling is observed. May have to reapply after heavy rainfalls.

**ALL SEASON USE!** Each application of Mole Scram should last 30 days including normal rainfall or irrigation.

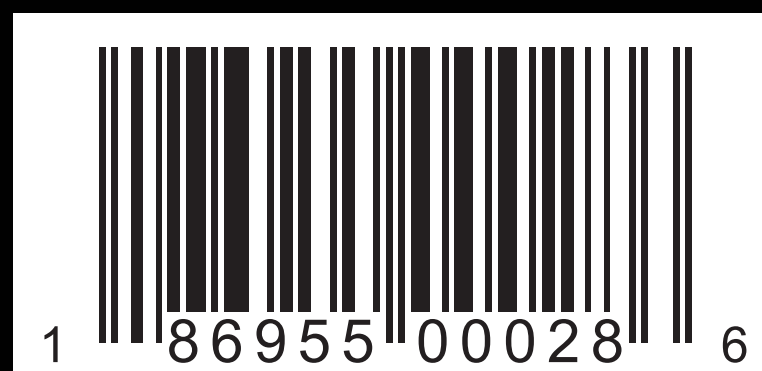
